The Intergovernmental Authority on Development (IGAD) has received financing from the African Development Fund, *hereinafter* called the Bank, toward the cost of the Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa, Project II (DRSLP II). Save the Children International, as an Implementing Agency (IA), intends to apply part of the proceeds of the project toward payments under the contract for the **Supply and Installation of Office Furniture and Equipment for the Mogadishu Water Agency's Building in Mogadishu, Somalia.**
- 2. Save the Children International, Somalia Country Office now invites sealed Bids from eligible Bidders for the Supply and Installation of Office Furniture and Equipment for the Ministry of Energy and Water Resources' Headquarters in Mogadishu, Somalia
- 3. Bidding will be conducted through the Open Competitive Bidding (National), (OCBN) procedures as specified in the Bank's <u>Procurement Framework</u> dated October 2015 and is open to all eligible Bidders as defined in the Procurement Framework.

The method of payment will be a direct payment to the SCI office in Mogadishu town.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on March 21, 2023, at 10:00 hrs. local time.
- 7. All Bids must be accompanied by a Bid Security in the form of an unconditional bank guarantee enforceable in Somalia using the format provided in the Bidding Document and in the amount of **US Dollars of 1,500**.
