The Intergovernmental Authority on Development (IGAD) has received financing from the African Development Fund, *hereinafter* called the Bank, toward the cost of the Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa, Project II (DRSLP II). Save the Children International, as an Implementing Agency (IA), intends to apply part of the proceeds of the project toward payments under the contract for the **Supply, Delivery, Installation and Commissioning of a Hybrid Power System (1) for One Borehole in Horufadhi Village in Buuhoodle District**.

3. Bidding will be conducted through the Open Competitive Bidding (National), (OCBN) procedures as specified in the Bank's [Procurement Framework](#) dated October 2015 and is open to all eligible Bidders as defined in the Procurement Framework.
