The Intergovernmental Authority on Development (IGAD) has received financing from the African Development Fund, *hereinafter* called the Bank, toward the cost of the Drought Resilience and Sustainable Livelihoods Programme in the Horn of Africa, Project II (DRSLPII). Save the Children International, as an Implementing Agency (IA), intends to apply part of the proceeds of the project toward payments under the contracts for the **Construction/ Rehabilitation of Ten (10) Sand dams in the Togdheer Region in Somaliland (Two Lots)**.
2. Save the Children International's Hargeisa office now invites sealed bids from eligible bidders for the **Construction/ Rehabilitation of Ten (10) Sand dams in the Togdheer Region in Somaliland (Two Lots)**:  
✓ **Lot#1: Five (5) Sand Dams in Ceelxume (1), Beerato (1), Xaaxi (2) and Qaloocato (1) villages.**  
✓ **Lot#2: Five (5) Sand Dams in Wisil (1), Wadhan (1), Ceel-bilcinle (1) and Ceel-dheere (2) villages**
3. Bidding will be conducted through the Open Competitive Bidding (National) (OCBN) procedures as specified in the Bank's [Procurement Framework](#) dated October 2015 and is open to all eligible bidders as defined in the Procurement Framework.

The method of payment will be a direct payment to the SCI office in Hargeisa town.  
**Notes: (1) The bidding document requested via email will not require payment of fees. (2) All sand dams shall be implemented in parallel within a 5-month completion period.
